Notice is hereby given that Connecticut Port Authority (the "applicant") of 200 State Pier Road will submit to the Department of Energy and Environmental Protection an application under Section 22a-361 of the Connecticut General Statutes to conduct work in tidal, coastal or navigable waters of the state; 33 U.S.C. 1341 (401 Water Quality Certificate) to conduct an activity which may result in a discharge to certain waters of the State.

Specifically, the application proposes demolition of existing buildings, regrading of the site, construction of a heavy lift pad in the expanded area between the State Pier and CVRR Pier, maintenance dredging, installation of bulkheads, upgrades to electrical and water utilities and storm drainage, as well as associated mitigation measures. The proposed activity will take place at 200 State Pier property and around and between the State Pier and CVRR Pier in the Thames River/New London Harbor. The proposed activity will potentially affect coastal resources and aquatic habitats, including coastal hazard areas, developed shoreline, near shore waters, shellfish concentrations areas, wildlife resources and habitat, benthic habitat, and indigenous aquatic life, including shellfish and finfish of the Thames River.
